

General Terms and Conditions

1. Prices

All listed prices are quantity prices.

Price and delivery time of our offers are subject to confirmation.

All prices are ex stock.

Deposit packaging like euro pallets or skeleton containers is not included in the price.

2. Conclusion of the Agreement / Order Confirmation

All offers are non-binding and valid while stock lasts.

The agreement shall be concluded when the customer places an order and the Wage – historische Baustoffe company confirms the order.

The customer shall place the order in writing by email.

Orders have to be confirmed in writing by us.

Wage – historische Baustoffe shall confirm the order by email.

3.1 Delivery

Unless otherwise agreed delivery shall be ex stock. The goods shall be delivered to the address given by the purchaser. In case of partial deliveries, the customer shall be informed about partial quantities and additional delivery dates. The purchaser shall accept the goods immediately or at the agreed delivery date. The purchaser shall provide for the immediate unloading.

The purchaser has to report damaged goods to Wage – historische Baustoffe immediately after receiving the goods. Later reclamations are not accepted.

If the purchaser picks up the goods himself or assigns a carrier himself, the risk shall be transferred to the purchaser immediately after loading the goods.

The customer shall make sure that the deposit packaging will be exchanged immediately at delivery; otherwise the customer shall bear the deposit costs for the euro pallets or skeleton containers.

3.2 Delivery Time

All orders received shall be processed as soon as possible. Standard delivery (national) is 10 working days after receipt of payment.

Delivery times for international deliveries can be requested individually. If an item is not in stock or if the delivery delays, we shall inform you about the exact delivery time by phone or by email.

3.3. Warehouse Expenses / Provision

In case the delivery is postponed by the customer, Wage – historische Baustoffe reserves the right to charge provision or warehouse fees for the building materials held available as of the 20th working day.

4. Payment

If the goods are shipped, payments shall be made by wired transfer; if the goods are picked up, payment shall be made in cash.

Other payment methods may be agreed upon.

5.1 Shipping

The goods shall be shipped by Wage – historische Baustoffe or by one of our carriers.

5.2 Shipping Costs

Shipping costs are subject to weight, dimensions and quantity.

5. Reclamations / Replacements

The goods shall be inspected immediately after receipt.

Reclamations shall only be accepted within 14 days and before any further processing of the goods.

6. Reservation of Title

Wage – historische Baustoffe reserves the title to the purchased goods until full payment of the goods and of all additional items of the same order by the customer.

7. Final Provisions

In the event that one or several provisions of these Terms and Conditions is/are null and void, the effectiveness of the entire agreement shall not be affected. The ineffective provision shall be replaced by an effective provision that represents the implied intention of the parties. The agreement shall be solely governed by German law; the application of the United Nations Convention on Contracts for the International Sale of Goods (CISG) is expressly excluded. Place of jurisdiction and performance shall be our domicile.
